WAIVER OF LIABILITY

Tri-City Court Club Policy: Tri-City Court Club shall not be held liable for any injury incurred in any exercise class, or any other use of equipment or facilities of the Club. Tri-City Court Club shall not be liable for any lost or stolen goods that may have been left or taken from the facility. Guests are encouraged to lock their valuables in a locker. Guests under 18 must have a parent or guardian sign the release waiver before using the club or participating in a birthday party.

Release Waiver: I, on behalf of myself and/or as parent or legal guardian of said minor child, understand and acknowledge that I possess full knowledge of the risk(s) of physical injury that are associated with such activities that are present in a Club environment and expressly agree to assume such risk(s) as well as assume and pay all medical and emergency expenses. "I have read and agree to the above release waiver."

Rock Wall Waiver: I am fully aware that rock climbing and related activities are potentially hazardous activities and I or my child is voluntarily participating in these activities with knowledge of the danger involved, and hereby agree to accept any and all risks of injury or death. **INITIAL HERE** _____

I agree that I will not sue, or otherwise make any claim against Tri-City Court Club, or their employees, agents, sponsors, or contractors, for injury or damage resulting from the negligence or other acts, however caused, by myself, any employee, agent or contractor of the above listed individuals or organizations as a result of my participation in any and all climbing activities and climbing programs involving Tri-City Court Club.
